### Project description:

The project SEPlaM-CC is implementing within the Interreg V-A Hungary-Croatia Co-operation Programme 2014-2020. The main goal of the project is to raise capacity of cross-border public institutions in sustainable energy planning and management and climate change mitigation by exchange of experience, knowledge and best practice examples. The implementation of project activities is also aiming at encouraging the planning and implementation of measures to increase energy efficiency and the use of renewable energy sources in the public and private sector. Medjimurje Energy Agency Ltd. is participating in the project as lead partner and the other partner from Hungary is Zala County Foundation for Enterprise Promotion. The total budget of the project is 176,075.35  $\in$  (EU contribution amounts to 149.664,04  $\in$ ). The project implementation started on 1st of July 2020 and will last until 28th of February 2022 when the implementation of all project activities will be completed.

As we all know, the local and regional authorities play the main role in energy planning and climate change mitigation so they will be directly involved in the implementation of project activities by development of Sustainable Energy and Climate Action Plans (SECAPs) for two local government units in HU-HR cross-border area. Through development of SECAPs the concrete measures for increasing energy efficiency, use of renewable energy sources and climate change mitigation with timeframes and assigned responsibilities in the administrative area of local government units will be defined. In addition, within the project the cross-border networking and educational workshops will be organized in order to ensure the cooperation between experts from various fields and to increase the capacity of public employees involved in development of strategic and planning documents in the field of energy and climate change mitigation.

Sustainable energy planning and climate change mitigation are the two biggest problems nowdays, and the key to success in overcoming the challenges arising from these problems lies in the adoption of appropriate strategic and planning documents at local, regional and national level and in successful implementation of measures defined in those documents. The basis for effective energy planning and climate change mitigation as well as for development of relevant strategic and planning documents in the cross-border area is the development of a common cross-border methodology that includes the specifics of project partner countries, defines the activities and relevant stakeholder engagement during the whole process of energy planning and climate change mitigation. The main goal of this networking event is to establish an effective cooperation between relevant stakeholders in HU-HR cross-border area for the purpose of common methodology on strategy planning and SECAP development.
